

# Commitment to Relationships and Sexual Health Education Recognition Awards Essex Criteria

Essex Sexual Health Service are committed to supporting young people to have access to high quality, inclusive relationships and sexual health education (RSHE).

The RSHE recognition awards scheme works with an aim to increase educational staff's confidence to deliver RSHE related topics, to support educational establishments to have best practice relating to RSHE working towards a whole school approach to RSHE learning, ensuring to incorporate the voice of their pupils, and engaging with parents and carers to support further learning at home.

To recognise educational establishments participation to the programme and their commitment to RSHE, ESHS will then award the educational establishment with a Bronze, Silver or Gold Certificate, demonstrating their commitment to RSHE.

The programme is designed to support educational establishments to become self-sustainable in relation to RSHE, without the need for dependence on outside agencies delivering to their students, but rather any delivery from outside agencies should enhance the comprehensive programme that is already incorporated within the setting.

Feedback from young people tells us that RSHE is more effective when taught by willing and competent teachers that are confident, unembarrassed and able to teach correct biological facts and also explore relationship issues.

This scheme is accessible to all secondary and further education settings (including special schools and PRUs) within an Essex County Council Postcode, and works in line with Essex Healthy Schools provided by HCRG.

## **Bronze Criteria**

- ▶ 10% of the educational staffing (minimum of 2 staff depending on size of establishment) to attend 2 training sessions from the Essex Sexual Health Service CPD RSHE professionals training catalogue.
- One of the above mentioned professionals training sessions must include either 'Delivering Relationships and Sexual Health Education' full length session or, for special schools, 'RSHE: Supporting Individuals with Additional Needs and Disabilities' full day session.
- That the educational establishment have liaised with parents and carers regarding their RSHE delivery and have allowed opportinities for parent and carer feedback and involvement. This is to include signposting to where the educational establishments RSHE Policy can be found, and sharing of the parents and carers online platform where parents and carers can access further learning eshs.org.uk/parents-and-carers
- To continue to actively deliver LGBTQ+ Inclusive RSHE in line with the National Curriculum and government guidance and to be able to provide evidence about how this is differentiated for learners with SEND. RSHE be given regular curriculum time like any other subject, encompassing a spiral curriculum where learning is revisited and built upon each year.
- > RSHE to be given regular curriculum time like any other subject, encompassing a spiral curriculum where learning is revisited and built upon each year.







# Silver Criteria

- To have achieved Bronze Award criteria and to be maintaining principles outlined above (see Bronze Criteria).
- > For all 6 (see below list) ESHS CPD RSHE training sessions to have been attended by members of the educational staffing body.
  - // Delivering RSE (full session)
  - // RSHE: Support people with additional needs and disabilities (full session)
  - // Sex Consent & Confidentiality
  - // STIs Contraception & Local Sexual Health Services
  - // Growing up in an Online World
  - // LGBT+ Inclusivity and Sexual Health

These sessions can all be attended by a single staff member or, alternatively attendance can be shared between multiple staff members.

- For the educational establishment to provide evidence that they have created opportunities to hear the voices of the student body relating to RSHE, this can be through focus groups, session feedback forms, suggestion boxes, participation in the ECC RSHE surveys. - > For the educational establishment to provide opportunity for further informal learning opportunities for students on RSHE subjects, including ensuring resources are visible and available to students through posters, leaflets, or specialist services hosting health promotion stands. Further Education establishments could also become eC-card distributors.





## **Gold Criteria**

- > To have achieved Silver Award criteria and to be maintaining principles outlined above (see Silver Criteria).
- > For the educational establishment to provide evidence that they have responded to young people's views and feedback, this could include initiatives such as increasing the number, and subject content of dedicated RSHE specialist sessions available to the pupils, engaging with additional outside specialist providers, setting up dedicated LGBT+ safe spaces, having more RSHE related health promotion visibility around the school, implementing changes following ECC RSHE survey.
- > For the educational establishment to host opportunity for parents and carers to learn more about RSHE, this could include a virtual learning session, inviting parents and carers in for an RSHE talk, RSHE resource table available at parent and carers evenings.
- > To evidence a whole school approach, of which demonstrable criteria can be found below. This can include evidence of working with the school nurse to support young people around relationships, sex and health.

An educational establishment cannot apply straight for the RSHE Recognision Gold Award without first achieving Bronze and Silver status. However, apllications for all three award levels can be made at the same time by establishmenst that have met all criteria.

If an educational establishment fulfils the criteria for an award, it is their responsibility to complete the recognition application form and return this to provide.eshsoutreachteam@nhs.net, applications will be reviewed at the end of every school term.

The programme runs from the begining of the accademic year until the end of the accademic year. Establishments achieving a recognition status within any academic year will be able to display their achievement during the remainder of the year achieved and into the following academic year. Although able to display the previous years achievement from the start of a new academic year, the establishment must again start working towards and evidencing their adherence to the criteria in order to reapply for that new academic years certificate.
